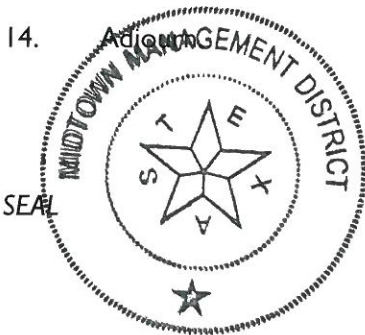
1. Call roll of the Board of Directors and verify that a quorum is present.
